- Replace your SASSA Gold Card for a Postbank Black Card at any authorised outlet during the Competition Period.
- Existing Postbank Black Cardholders are automatically entered into the draw.
- No additional purchases or costs are required for entry.
- Participation is **free**, and obtaining the Postbank Black Card does not incur additional costs or obligations.

3. Prizes
